On Thursday, 30 May 2024, the IHL RED Consortium (IHL Legal Clinics at Bochum, Leiden and Roma Tre University) is hosting a hybrid Conference, with the support of the International Committee of the Red Cross, to discuss with IHL academics and humanitarian organizations opportunities and challenges of clinical legal education in International Humanitarian Law.

Based on an overview of activities carried out by existing IHL Legal Clinics and an analysis of recurring issues for IHL legal clinical education, the Conference hosted both virtually and at Roma Tre University will permit to critically discuss opportunities and challenges IHL academics might face in managing an IHL Legal Clinic and present to potential partner humanitarian organizations the benefits and practicalities of collaborating with IHL Clinics.

The conference will also permit launch a series of freely available resources developed by the <a href="https://example.com/IHL RED">IHL RED</a> Consortium to help successfully create and manage an IHL Legal Clinic.

As to facilitate the debate, a preliminary <u>survey</u> on existing IHL Legal Clinics has been arranged. IHL legal clinic professors are kindly invited to fill the survey by 5/5. Results will be circulated in advance to the conference to pave the way for discussions during the Conference and get an overview of the worldwide IHL legal clinics movement.
